NOTIFICATION

REGISTRATION FOR SPECIAL INSTRUCTION CLASSES, 2026

Registration for Special Instruction Classes for December 2025 was notified vide Notification No. GDU/DoE/2025-26/11 dated 19-09-2025. As per the notification, all eligible students were permitted to register for up to six courses. The Special Instruction Classes were conducted from 06 October 2025 to 30 November 2025, and the End Examinations were scheduled from 16th December 2025 to 31st December 2025.

As communicated, the final attempt for the remaining courses of all UG and PG students across schools will commence from **01st Jan 2026**, Students may register for a maximum of six (6) courses, excluding MOOC courses. The maximum grade attainable for the UG students from 2021- 22 Admitted batches of GSB, GSCSE, GSCE, GSHSS, and GSS courses is B+, and for remaining students Continuous Evaluation (CE) marks will be considered up to 50% of the total CE marks for these courses.

UG Programs of GSA, GSL - Admitted Batch from 2019-2020

UG Programs of GSCSE, GSCE, GSP, GSS, GSHSS - Admitted Batch from 2020-2021

UG Program of GSB, GSHSS, GSS - Admitted Batch from 2021-2022

PG Programs of GSA, GSCSE, GSCE, GSHSS, GSL , GSP, GSS - Admitted Batch from 2022-2023

Six courses are offered in October 2025 and offering another six courses not having sufficient Continuous Evaluation (CE) marks in January 2026 as a final opportunity for students to clear courses. In total, students are provided the chance to clear up to 12 courses. If any student has more than 12 courses, the remaining courses must be attempted through a 100-mark examination scheduled in the month of June.

Eligibility criteria to register for the courses:

- a) Students who have not cleared the CE component
- b) Students with credit deficiency

Note: This is the last opportunity for students to register for the Special Instruction Classes. Thereafter, any backlog students must register for the 100-mark supplementary examination in the month of June only, even if the student already have sufficient CE marks, which will be nullified.

Schedule:

a) Special Instruction Classes: **01st Jan 2026 – 10th Feb 2026** (Minimum 90% attendance is mandatory to be eligible for End Examination.)

b) End Examinations: Commence on **02nd March 2026**

c) Detailed timetable will be released on **03rd February 2026**

Students are advised to contact their respective Head of Department for the Special Instruction class timetable.

Examination Fee Structure:

a) MOOC Courses	: ₹3000 per course
b) Courses with CE component only	: ₹6500 per course
c) Courses with CE and SEE components	: ₹7700 per course
