#### SUPPLEMENTARY EXAMINATIONS, JUNE 2026

Reference is made to the Registration for Special Instruction Classes Notification GDU/DoE/2025-26/20 and the Supplementary Examination Notification GDU/DoE/2025-26/21 Dated: 17-12-2025. As per the notifications, students having backlogs are eligible to attend for the **Supplementary examinations in June 2026**.

Supplementary Examinations for all the UG and PG students of School of Business will commence from the first week of June 2026. Students may register for a maximum of eight (8) theory courses, excluding Continuous Evaluation (CE) courses. However, this course limit does not apply to the passed out students. The grade cap is applicable.

- Students who have not cleared the Courses (T, P, or TP)
- Students with credit deficiency
- Non-exempted courses of Lateral - Entry/ Inter University Transfer Students

- Practical Courses: Conducted by the School. Students are advised to contact their Head of Department for CE course examinations.
- Examinations will commence from first week of June 2026.
- Detailed timetable will be released on **21<sup>st</sup> April 2026**.
- Last date for Registration: **15<sup>th</sup> April 2026**
