NOTIFICATION**SCHOOL OF HUMANITIES AND SOCIAL SCIENCES
SUPPLEMENTARY EXAMINATIONS, OCTOBER 2026**

Reference is made to the **Academic Regulations**, which stipulate that all Supplementary Examinations shall be scheduled only in the month of **June** of the respective academic year. In view of the above, the **Competent Authority has granted a special provision for the current academic year**, permitting the present final-year students and passed-out students to register for the **Supplementary Examinations scheduled in October 2026**. Students having backlogs may apply for the **Supplementary Examinations**.

Supplementary Examinations for all the UG and PG students of School of Humanities and Social Sciences will commence from the first week of October 2026. Students may register for a maximum of eight (8) theory courses, excluding Continuous Evaluation (CE) courses. However, this course limit does not apply for the passed out students. The grade cap is applicable.

- End Examinations: Commence from 14th October 2026**
- Detailed timetable will be released on **26th September 2026**

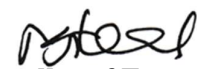
